SUMMARY OF SPECIAL PROCEDURE (INCLUDING REGITRATION OF MACHINES) TO BE FOLLOWED BY MANUFACTURERS OF TOBACCO, GUTHKHA, PAN MASALA etc.

Exercising powers conferred by Sec.148 Central Govt. on recommendations of GST Council, have notified following special procedure via NNO. 04/2024 effective from 1st April 2024 to be followed by Manufacturers of goods mentioned in schedule of the Notification (i.e.Tobacco, Pan Masala, Guthka etc.)

 Furnishing details electronically on common portal – A unique registration number will be generated for each Machine

- Special Monthly Statement To be filed electronically on portal in special statement for each month in FORM GST SRM-II, on or before the tenth day of the month succeeding such month.
- Certificate of Chartered Engineer.
 - (1) The taxpayer shall upload a certificate of Chartered Engineer FORM GST SRM-III in respect of machines declared by him, as per this notification, in Table 6 of FORM GST SRM-I
 - (2) If details of any machine are amended subsequently, then fresh certificate in respect of such machine shall be uploaded.
